Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorari calling for the records pertaining to the impugned order passed by the 2nd respondent vide his proceedings in Na.Ka.No.109/Siva/Va.Ka/Rama.Saragam/2019, dated 30.10.2019 and quash the same as illegal.

Prayer in WP(MD). 23266/ 2019 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus directing the 3rd respondent to include the Petitioner's name in the voters list prepared by the 3rd respondent for election of Pudur Periya Pallivasal, Pudur, Ilaiyankudi, Sivagangai District on the basis of his representation dated 21.10.2019 .
