ORDER

This Criminal Original Petition has been filed to direct the learned Sessions Judge, Special Court for Exclusively Trial of Cases under SC/ST (PoA) Act, Ramanathapuram District, to consider the Petitioners' bail application on the same day of surrender in Crime No.187 of 2022 on the file of the second Respondent.

2.When the case came up for hearing, the learned Government Advocate for the Respondents 1 and 2 would submit that the injured has been discharged from the hospital and the Petitioners have no previous case.

ii) On such surrender by the Petitioners, the learned Sessions Judge, Special Court for Exclusively Trial of Cases under SC/ST (PoA) Act, Ramanathapuram District, shall consider the bail application of the Petitioners and dispose of the same as per law.
