A perusal of the representation indicates that the respondents 4 and 5 were the President and the Vice President of the concerned Panchayat. They are alleged to have misappropriated the Panchayat funds and also obtained houses under the Indira Awas Yojana Scheme.

3. In view of the above said facts, the 1st respondent is directed to consider the representation of the petitioner, dated 29.06.2015 and pass
