proportionate accrued interest, to the credit of M.C.O.P.N of 2017 on the file of the Motor Accidents Claims Tribunal, Principal Subordinate Court, Tenkasi, less any amount already deposited from the date of receipt a copy of this order, failing which, interim stay granted shall stand automatically vacated.
