ORDER

This Criminal Original Petition had been filed to direct the Respondents to produce the mobile phone of the Petitioner's son/deceased before the learned Judicial Magistrate, Rameshwaram in Crl.MP.No.3442 of 2022 and to direct the Trial Court for speedy disposal of the case in Crl.MP.No.3442 of 2022.

2.It is the submission of the learned Counsel for the Petitioner that the Petitioner's son died in suspicious circumstances. The Respondents had closed the case as accidental death. The Petitioner had filed Crl.M.P.No. 3442 of 2022 before the learned Judicial Magistrate, Rameshwaram, seeking the mobile phone of her son. The Petitioner had filed the protest petition regarding the closure report of the Respondents.
