ORDER

This Writ Petition has been filed for issuance of a Writ of Mandamus, directing the first respondent to dispose the petitioner's appeal dated 26.09.2022, which was filed against the second respondent order in Na.Ka.No.73/22, dated 24.03.2022 within a reasonable time.

2. The case of the petitioner is that he has made an application to the second respondent on 02.11.2021, for cancellation of the gift deed ie., Doc. No.567/2003, dated 19.05.2002, registered at third respondent Sub Registrar Office. But the same was rejected by him through Na.Ka.No. 73/22, dated 24.03.2022. Challenging the same, the petitioner has filed an appeal before the first respondent on 26.09.2022 and the same is still
