Today, when the matter was taken up for hearing, the learned counsel for the petitioner submitted that it would suffice if a direction is issued to the first respondent to consider and dispose of his representation dated 14.09.2022, in the light of the letter dated 24.02.2022 in Na.Ka.H2/3344/2020 of the second respondent, on merits and in accordance with law, within a time frame.

Considering the limited relief sought for by the petitioner, this Writ Petition is disposed of with a direction to the first respondent to consider the representation of the petitioner dated 14.09.2022, in the light of the letter dated 24.02.2022 in Na.Ka.H2/3344/2020, and pass appropriate orders on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order. No costs.
