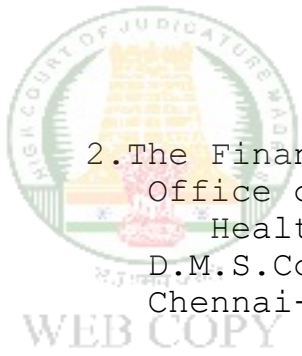

2.Recording the said submission, the Writ Petitions are closed. No costs. Consequently, connected miscellaneous petitions are closed.

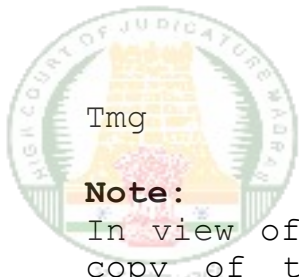
