The case of the petitioner is that she has made a representation to the second respondent on 04.05.2021, seeking Patta to her house bearing Old No. 2/126-B and New No.2/127 of Karungadal Village Panchayat situated to an extent of 2 ½ cents comprised in Natham Survey No.860/26 of Karunkadal Village, Santhankulam Taluk, Thoothukudi District. Since no action was taken, the present writ petition has been filed.
