ORDER

When the matter is taken up for hearing today, the learned Additional Government Pleader appearing for the respondents 1 and 2 would submit that already the property in Survey Nos.96/1 and 99/1 in joint Patta No.1517 situated in Sempoothi Village, Ponnamaravathi Taluk, Pudukkottai District was surveyed on 20.09.2021.

3. Considering the above said submission, this Court is of the view that the petitioner's prayer for measuring the property again and again cannot be
