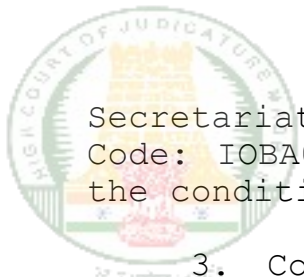
Prayer CRL MP(MD). No.13419 of 2022 in CRL OP(MD). No.8250 of 2022:-
