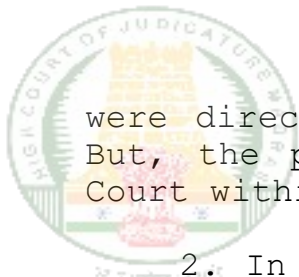
Prayer CRL MP(MD). No.13405 of 2022 in CRL OP(MD). No.8324 of 2022:-

The learned Counsel for the Petitioners have filed this Petition seeking extension of time to deposit Rs.5,000/-. It is the contention of the learned Counsel for the Petitioners that he had filed the quash petition in Crl.O.P.(MD) No.8324 of 2022 before this Court and the same was allowed on 29.04.2022 and the Petitioners



were directed to pay a sum of Rs.5,000/- on or before 30.04.2022. But, the petitioners were unable to comply the direction of this Court within the stipulated time.

2. In view of the same, further period of two weeks is granted to the Petitioners to pay a sum of Rs.5,000/- as per the order dated 29.04.2022 in Crl.O.P.(MD) No.8324 of 2022 from the date of receipt of copy of this order.
