2. The first respondent has filed a counter affidavit, dated Nil. 01.2019, wherein, in Paragraph No.4, he has stated as follows:

“4.I further submit it is pertinent to mention that the Government of Tamilnadu also issued a G.O.No.142, Environment and Forest (FR-6), dated 29.11.2016 has sanctioned a sum of Rs.1.38 Crore for proper implementation of the scheme of raising Palmyrah pal tree plantation and by following the said scheme large number of palm trees are cultivated under strict supervision of the officials of the Forest Department.”
