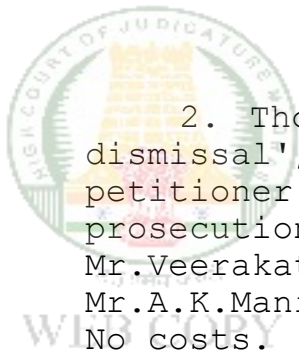
O R D E R

When this matter was called on 31.01.2022, absence of the petitioner has been recorded and the following order has been passed by me:

" Petitioner is called absent.

2. Prima facie the Mandamus sought for by the petitioner is not liable to be granted. The petitioner seeks appointment as a Grade-II Police Constable/Grade-II Jail Warder/Fireman, by considering his representation, dated 17.09.2018. However, at para-8 of the affidavit, he states that his claim for appointment was rejected on 24.10.2017 in proceedings in Na.Ka.No.A3/9645/2017. This order remains unchallenged.

3. To afford an opportunity, list on 03.02.2022 under the caption 'for dismissal' ".



2. Though the matter was listed today under the caption 'for dismissal', there is no appearance by or on behalf of the petitioner. Hence, this Writ Petition is dismissed both for non-prosecution as well as for the reason set out above as reiterated by Mr.Veerakathiravan, learned Additional Advocate General for Mr.A.K.Manikkam, learned Special Government Pleader for the State.
