3.Heard the learned Counsel appearing for the Petitioner, learned Additional Public Prosecutor for the Respondent and perused the materials available on record.

4.Considering the nature of offences alleged against the Petitioner, this Criminal Original Petition is allowed. The Petitioner is directed to surrender before the Juvenile Justice Board/Judicial Magistrate, Theni within a period of 15 days from the date of receipt of copy of this order or 15 days from the date of uploading the order copy on the web-site of this Court. The learned Judge shall consider the bail application of the Petitioner
