2.The learned Additional Public Prosecutor submitted that when the Petitioner appeared before the first Respondent, the Petitioner had not furnished the certificates regarding the qualification to maintain a SPA.

3.In the light of the submissions made by the learned Additional Public Prosecutor, the Petitioner is directed to gave a fresh representation to the first Respondent along with proper certificates regarding his qualification to run or maintain a SPA (Ayurvedha Massage Centre). The Respondents 1 and 2 are directed to consider the representation/application of the Petitioner, if he furnished with proper certificates regarding his qualification in Ayurvedha or any other similar

Health Science and shall pass appropriate orders within a reasonable period of one month from the date of receipt of a representation given by the Petitioner.
