2.The Petitioner is the accused for the offences punishable under Sections 294(b), 323 of IPC r/w.Section 4 of TNPHW Act r/w.Sections 3(1)(r), 3(1)(s), 3 (2)(va) of SC/ST (PoA) Amendment Act, 2015 in Crime No. 164 of 2022, pending on the file of the second Respondent Police and apprehending arrest, he has filed the present Petition.

3. Heard the learned counsel appearing for the Petitioner, the learned Additional Public Prosecutor and perused the materials available on record.
