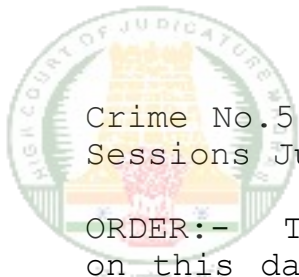
Prayer in CRL MP(MD). No.13617 of 2022:-
