This Petition has been filed by the Petitioner seeking direction against the Respondent/Investigation Officer to complete the enquiry in Crime No. 51 of 2020 and file the final report within the time to be specified by this Court.

2.The learned Government Advocate (Crl. Side) appearing for the Respondent/Investigation Officer submitted that the case is registered under Sections 381, 403, 406, 409, 408, 468, 417, 465 and 466 of IPC. So far 208 witnesses have been examined and some more witnesses are yet to be examined.
