ORDER

This Habeas Corpus Petition has been filed by the husband of the detenu seeking for a direction to the respondent police to secure his wife Shanmugapriya, aged about 24 years, who is said to have been missing from October, 2022 onwards.

2. When the matter was taken up for hearing, the detenu was produced before this Court. The detenu is aged about 25 years and she is a practising Advocate. She stated that there was some relationship with the petitioner and that the petitioner had forcibly married her. The detenu

further stated that she is not willing to go along with the petitioner and she on her own volition has gone back to her parents home.
