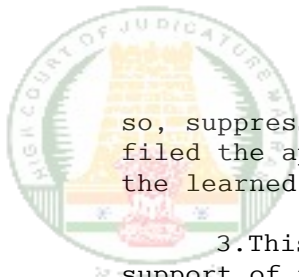

ORDER : The Court Made the following order :-

The civil revision petition is proposed to be filed as against the proceedings, which is pending before the Tahsildar cum Record Office, Tamil Nadu Agriculture Land Receipts of Tenancy Rights, Madurai North, Madurai.

2.Learned Counsel for the petitioner submitted that the petitioner is the owner of the properties in S.Nos.28/3 & 28/4A. She purchased the properties by way of a registered sale deed in the year 1980 and patta also stands in her name. While



so, suppressing these materials and behind her back, the respondents 2 & 3 filed the application as against the respondents 4 & 5, who are her sons. Hence, the learned Counsel seeks leave of this Court.

3. This Court is satisfied with the reasons assigned in the affidavit filed in support of the petition. Accordingly, this miscellaneous petition stands allowed.
