In view of the same, the Petitioner can very well go before the Civil Court for necessary relief in the suit filed by her and hence, the orders of this Court made in the above Writ Petition has been complied with and as such no contempt is made out.

4.In view of the above, the Contempt Petition is closed. No costs.
