The Criminal Original Petition has been filed, invoking Section 482 Cr.P.C, seeking orders to call for the records relating to the impugned proceedings in No.A5/M.C.No.327/2019, dated 07.11.2019 (107) on the file of the first respondent and quash the same against the petitioners.
