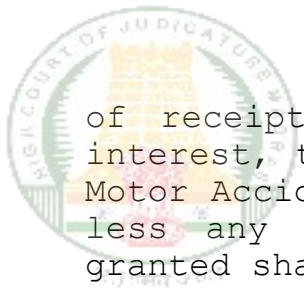
Prayer in CMA(MD). 1081/ 2022 :
