4.In the light of the submission made by the learned Government Advocate (Crl.Side), the Petitioner is directed to surrender before the learned II Additional District and Sessions Judge, PCR Court Cases, Tirunelveli, within a period of fifteen days from the date of receipt of a copy of this order or from the



date of uploading of this order in the website of this Court. On such surrender and filing an application seeking bail, the learned II Additional District and Sessions Judge, PCR Court Cases, Tirunelveli, shall issue notice to the defacto complainant and pass appropriate orders as per law.

5. With the above direction, this criminal original petition is allowed.
