2. By consent of both parties, the writ petition itself is taken up for final disposal.



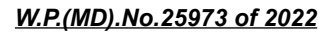

3. The case of the petitioner is that he has given a detailed representation dated 10.09.2022, to the first respondent seeking to cancel the Patta issued in favour of the fourth respondent in respect of the property in S.No.93/4 to an extent of 2 acres situated at Kadamalaikundu Village, Aundipatti Taluk, Theni District. Subsequently, the first respondent sent a communication to the second respondent to take action by his proceedings in Na.Ka.No.87669/2022/D2, dated 15.09.2022 and the same is still pending. Hence, the present writ petition has been filed by the petitioner.

4. The learned Additional Government Pleader appearing for the respondents 1 to 3 would submit that the petitioner's representation dated 10.09.2022, will be considered by the second respondent within a period of eight weeks.
