When the matter is taken up for hearing today, Mr.D.Gandhiraj, learned Special Government Pleader appearing for the fifth respondent would submit that the petitioner's representation has been considered and a recommendation has been made by the Special Tahsildar, Karaikudi to the District Collector, Sivagangai District in Na.Ka.No.1/1490/2021,
