2. Heard Mr.A.Haja Mohideen, learned counsel appearing for the petitioner and Mr.D.Gandhiraj, learned Special Government Pleader appearing for the respondents 1 to 4.

The case of the petitioner is that he is the owner of the property in Survey Nos.309/1A, 309/1B and 309/2B situated at Thogaimalai Village, Kulithalai Taluk, Karur District, by virtue of sale deed, dated 09.10.1978. He has applied with the respondents 2 and 3 for survey of the land, on 02.09.2020 and also paid necessary fees. Since there is no
