The Petitioner is directed to surrender before the III Additional Sessions Court and Special Court for Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Cases (PCR Court) Madurai within a period of 15 days from the date of receipt of copy of this order or 15 days from the date of uploading the order copy on the website of this Court. The learned Judge shall consider the bail application of the Petitioner and dispose of the same as per law. The III Additional Sessions Court and Special Court for Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Cases (PCR Court) Madurai , shall cause notice to the De-Facto Complainant regarding the bail application when the bail application is filed.
