This Criminal Original Petition had been filed to direct the learned Sessions Judge, Special Court for SC/ST(POA) Act, Thoothukudi to consider the bail application of the Petitioner on the same day of their surrender in Crime No.121 of 2022 on the file of the 1st and 2nd Respondents police.

2.The Petitioners are the accused for the offences punishable under Sections 147,447,294(b),323,506(2) of IPC and Sections 3(1)(r), 3(1)(s), 3(2)(v)(a) of SC/ST (PoA) Amendment Act, 2015 in Crime No. 121 of 2022, pending on the file of the second Respondent Police and apprehending arrest, they have filed the present Petition.

3. Heard the learned counsel appearing for the Petitioners, the learned Additional Public Prosecutor and perused the materials available on record.

The learned Judge shall consider the bail application of the Petitioners and dispose of the same as per law. The learned Sessions Judge, Special Court for SC/ST(POA) Act, Thoothukudi, shall cause notice to the De-Facto Complainant regarding the bail application when the bail application is filed.
