The prayer in the writ petition is for issuance of a writ of mandamus directing the respondents to repair the sub-standard main road at Sellur Kanmoi, Kulamangalam Main Road, Ward Nos.23 & 24, Madurai Corporation, by considering the petitioner's representations dated 10.06.2022 & 01.11.2022, within a time frame.

5. The grievance of the petitioner is that though he made representations, as early as on 10.06.2022 & 01.11.2022, to the respondents seeking to repair the sub standard Main Road, till date, the same have not been considered.

6. The learned Government Pleader appearing for the first respondent and the learned Standing Counsel appearing for the second respondent, on instructions, submitted that the petitioner's representations, dated 10.06.2022 & 01.11.2022, would be considered and appropriate action would be taken, in accordance with law.
