ORDER

(Order of the Court was made by N. ANAND VENKATESH,J.)

This Habeas Corpus Petition has been filed by the husband of the detinue seeking a direction to the respondent police to secure and produce the body of his wife, viz., Kalaiselvi, aged about 29 years, who is said to be in the illegal detention of the third respondent.

2.The learned Additional Public Prosecutor, on instructions, submitted that even on an earlier occasion, the detinue went missing with the third respondent and an FIR was registered by the 2nd respondent in Crime No. 110/2022. In the course of investigation, the whereabouts of the detinue was traced and she went along with the petitioner. Once again the detinue has eloped with the third respondent and already a complaint has been received from the petitioner in this regard. The learned Additional Public Prosecutor submitted that as and when the whereabouts of the detinue is traced, she will be taken to the concerned Magistrate Court and her statement will be recorded.
