2.The Petitioners are the accused for the offences punishable under Sections 147, 148, 294(b), 323, 324, 506(ii) IPC r/w Section 4 of TNPWH Act and Sections 3(1)(r), 3(1)(s) and 3(2)(va) of SC/ST (PoA) Amendment Act, 2015, in Crime No.430 of 2022, pending on the file of the second Respondent Police and apprehending arrest, they have filed the present Petition.

The learned Judge shall consider the bail application of the Petitioners and dispose of the same as per law. The learned Special Judge, Special Court for SC/ST (PCR Court)/III Additional District Sessions Court, Madurai, shall cause notice to the De-Facto Complainant regarding the bail application when the bail application is filed.
