Hence, Habeas Corpus Petition is filed alleging that the third and fourth respondents have kidnapped the petitioner's minor daughter.

When we enquired the minor girl, she stated that due to poverty, she on her own without informing the parents gone to Thirupur and she is working there. She is ready and willing to go along with her parents. The petitioner also appeared before this Court and stated that she is ready and willing to take her minor daughter back.
