2.The learned counsel for the petitioner would submit that the petitioner is complying with the condition without fail.

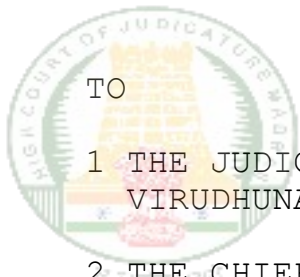
3.The above submission is admitted by the learned Government Advocate (Criminal Side) appearing for the respondent police.
