ORDER

Heard the learned counsel on either side.

2. The writ petitioner worked as Clerk in the respondent Corporation. She reached the age of superannuation on 31.01.2020. She had been denied the benefit of wage settlement for the period from 01.09.2016 to 31.12.2017. Claiming disbursement of the said benefit, the present writ petition has been filed.

3. Subsequently, settlement was entered into between the Union and the Management on 24.08.2022. But it was made applicable with effect from 01.09.2019. Therefore, the petitioner was also entitled to the benefit under the said settlement dated 24.08.2022. But her terminal benefits were settled
