ORDER

On such surrender and filing an application seeking bail, the learned Special Judge, Special Court for Exclusive Trial of Cases under SC/ST(Prevention of Atrocities) Act, 1969, Sivagangai, shall issue notice to the defacto complainant and pass appropriate orders as per law.

5. With the above direction, this criminal original petition is disposed of.
