ORDER

This revision petition is filed as against the order passed by the learned District Munsif, Kovilpatti, in I.A.No.194 of 2019 in O.S.No.30 of 2014, dated 24.09.2019, in and by which, the petitioner's plea to appoint an Advocate Commissioner was rejected.

2.When the matter came up for hearing today, learned Counsel for the petitioner submitted that the suit itself has been disposed of on 12.04.2022 and therefore, nothing survives for further adjudication in this revision. However, he sought for liberty to agitate his claim for appointment of Advocate Commissioner before the appellate forum.
