PRAYER IN CRL MP(MD) No.6645 of 2022:

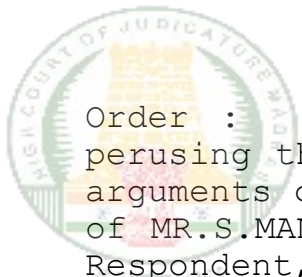
