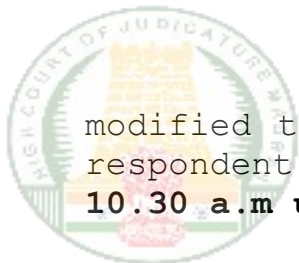

2. The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3. The learned Government Advocate (Crl.Side) would also submit that the petitioner has been complying with the the conditions.

4.Considering the said submission, the condition imposed by this Court in Crl.O.P.No.18251 of 2022 dated 28.10.2022, is



modified to the effect that the petitioner shall report before the respondent police **on the first & third Saturday of every month at 10.30 a.m until further orders.**

5. With the above directions, this criminal miscellaneous petition is ordered.
