2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents.

The learned counsel appearing for the petitioner would submit that on the basis of the complaint given by the petitioner, FIR came to be registered in Crime No.23 of 2022 against one Poobathi, who is working as Sub Inspector of Police, Thiruverumbur Police Station, Trichy District, for the offences under Sections 406, 468 and 471 IPC and that

after registering the FIR, the second respondent police has been taking action in a biased manner to support the accused and that is why he filed the present application.

6. With the above direction, this Criminal Original Petition stands disposed of.
