This petition has been filed to relax the condition imposed upon the petitioners in Crl.O.P.No.17999 of 2022 dated 11.11.2022, passed by this Court to report before the respondent police daily **at 10.30 a.m., until further orders.**

2.The learned counsel for the petitioners would submit that the petitioners have been complying with the conditions regularly and hence, he seeks for relaxation of the condition.



3. The learned Government Advocate (Crl.Side) would also submit that the petitioners have been complying with the the conditions.

4.Considering the said submission, the condition imposed by this Court in Crl.O.P.No.17999 of 2022 dated 11.11.2022, is modified to the effect that the first petitioner shall report before the respondent police **on every Saturday at 10.30 a.m until further orders.** Insofar as the petitioners 2 to 5 is concerned, the condition imposed by this Court in Crl.O.P.No.17999 of 2022 dated 11.11.2022, is relaxed to the effect that **the petitioners 2 to 5 shall report before the respondent police as and when required for interrogation.**

5.With the above directions, this criminal miscellaneous petition is ordered.
