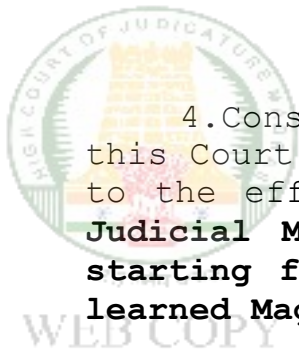

This petition has been filed to relax the condition imposed upon the petitioner in Crl.O.P.No.17399 of 2022 dated 29.09.2022, passed by this Court to report before the respondent police daily **at 10.30 a.m., until further orders.**

2.The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (Crl.Side) would also submit that the petitioner has been complying with the the conditions. Now, charge sheet has been filed before the learned Judicial Magistrate, Kuzhithurai.



4. Considering the said submission, the condition imposed by this Court in Crl.O.P.No.17399 of 2022 dated 29.09.2022, is modified to the effect that the petitioner shall **report before the learned Judicial Magistrate, Kuzhithurai, for a period of one week i.e., starting from 12.12.2022 and thereafter, on the date fixed by the learned Magistrate.**
