2. The learned counsel for the petitioner would submit that the petitioner has been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3. The learned Government Advocate (Crl.Side) would also submit that the investigation has been completed and the case was taken on filed in P.R.C.No.33 of 2022 on the file of the learned Judicial Magistrate No.V, Trichy.



4. Considering the said submission, the condition laid by this Court, in CrI.MP(MD)No.7814 of 2022 in CrI.O. No. 38 of 2022 dated 08.07.2022, is modified to the effect that the petitioner shall report before **(*)the Principal District Judge, Trichy**, daily at 10.30 a.m, for a period of one week i.e., starting from 08.12.2022 and thereafter, on the date fixed by the learned Magistrate.
