ORDER

This Criminal Original Petition has been filed, invoking Section 482 Cr.P.C., seeking orders to direct the respondent police to file a final report in Crime No.378 of 2020 on the file of the respondent police dated 11.10.2020 within stipulated time fixed by this Court.

2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent.

3. When the matter is taken up for hearing today, the learned Additional Public Prosecutor appearing for the respondent would submit that based on the complaint lodged by the petitioner, the respondent police registered an FIR in Crime No.378 of 2020. He would further submit that since the first accused is in abroad, they have issued look out circular, that they have already examined 8 witnesses and that investigation is in progress. Hence, he seeks three months time to file final report before the jurisdictional Magistrate Court.
