Prayer in CRL MP(MD). 15190/ 2022 :

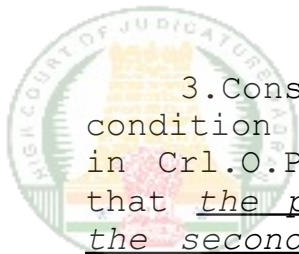
To modify the condition 6(b) in Cr1 OP(MD) No.18359/2022 on 17.10.2022 imposed on the petitioner.
