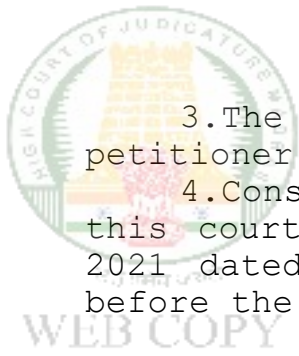
Prayer in CRL RC(MD) . 884/ 2021 :
