This Petition has been filed to extend the time for compliance of the order passed by this Court in Crl.O.P(MD).No.17132 of 2022, dated 26.09.2022.

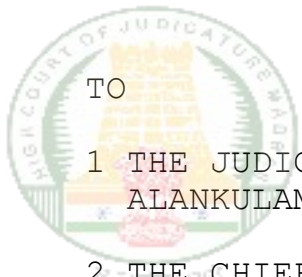
2 Heard both sides.
