ORDER

3.Heard the learned Counsel for the Petitioner and the learned Government Advocate (Crl.side) for the Respondents.

4.The learned Government Advocate (Crl.side) objects to the date of the event stating that the Hon'ble Chief Minister of Tamil Nadu intended to visit Southern Districts on 08.12.2022. Therefore, the Police Officials will be on bandobust duty from 07.12.2022 onwards. Therefore, they are unable to give protection or permission on 07.12.2022. He would further submit that the

5.In the light of the submission of the learned Government Advocate (Crl.side), the Petitioner is directed to give fresh representation with an alternate date to the Respondent Police for the said relief. On such receipt of the petition by the Petitioner, the Respondents are directed to consider the sane and pass appropriate orders as expeditiously as possible, in the light of the circular issued by the Director General of Police.
