ORDER

2. Heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor for the respondents.

3. The learned Additional Public Prosecutor appearing for the respondents would submit that they have already issued proceedings dated 13.11.2022 granting permission subject to the conditions imposed by this Court, considering the representation of one Ulaganathan.

4. In the proceedings dated 13.11.2022, though it has been stated that there was no permission for Adal Padal Programme, but immediately it has been stated that in case of conducting Adal Padal Programme, the
